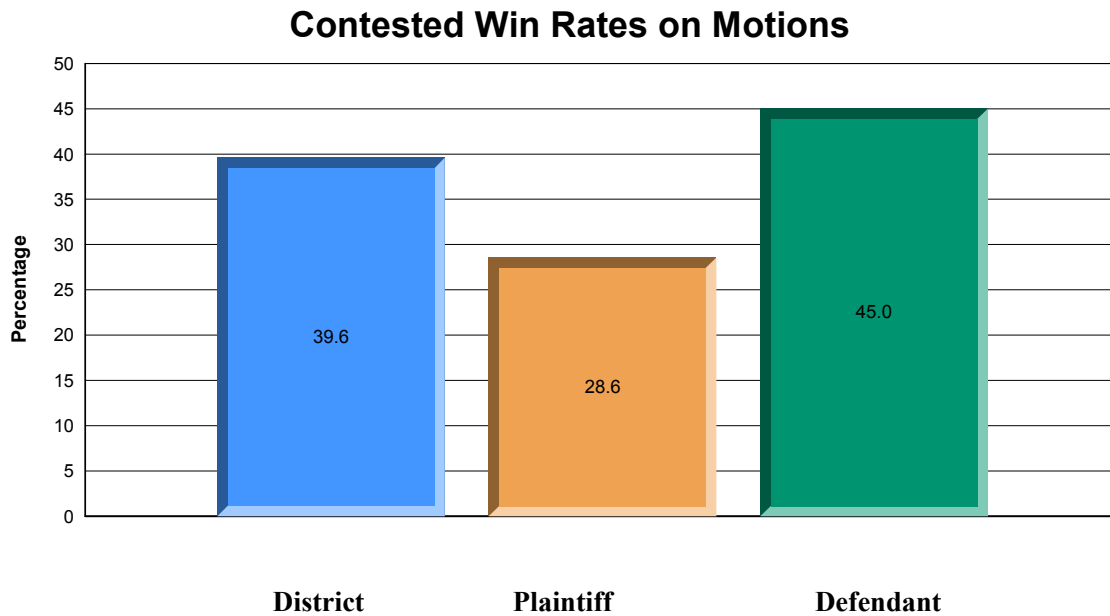

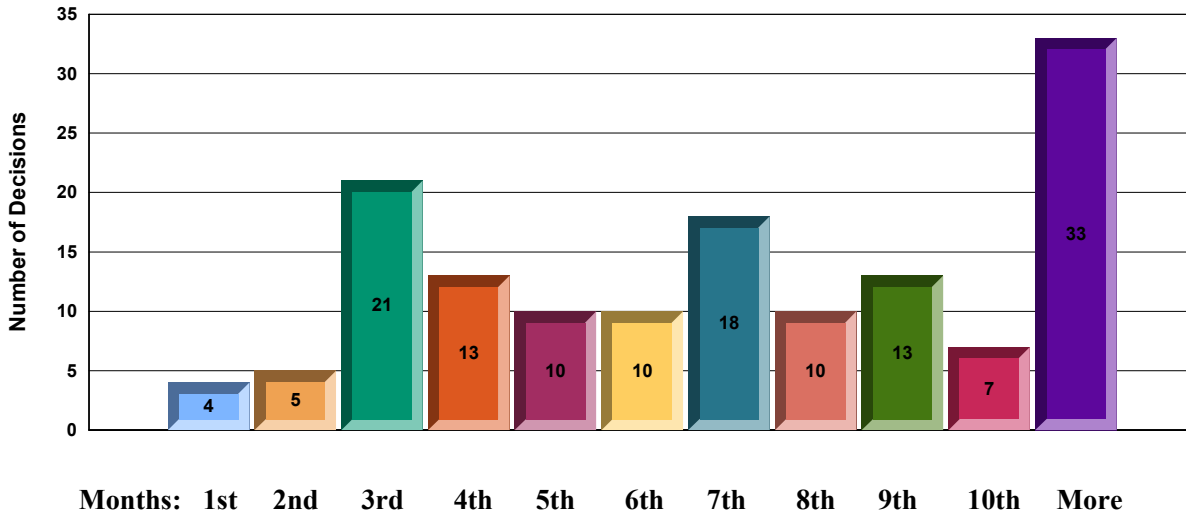
Overall Win Rate: 39.6%
