

Comparison of Percentage of Cases Terminated by Transfer

The average percentage of patent cases terminated by transfer nationwide is 4.4%. In those districts with at least 200 closed cases, the average percentage of cases terminated by transfer varies from 0.9% (District of Nevada) up to 12.9% (Eastern District of Virginia).


Percentage of Cases Terminated by Transfer: Districts with at Least 200 Closed Cases








The percentage of all patent cases transferred, by district, is illustrated in the map to the right. The actual percentage for each district is shown in tabular form below.
