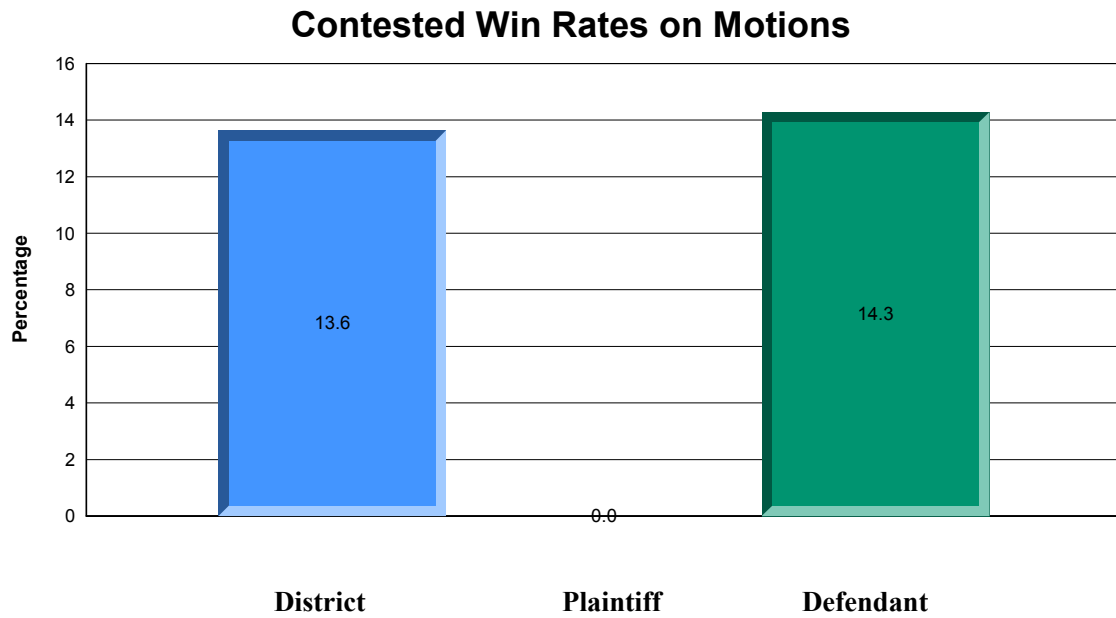

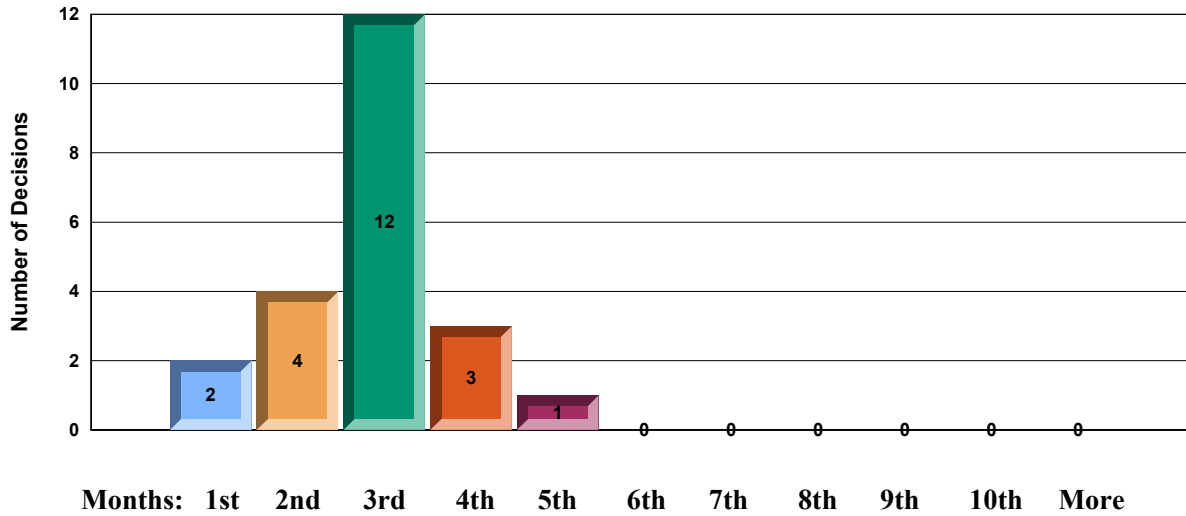
Overall Win Rate: 13.6%
