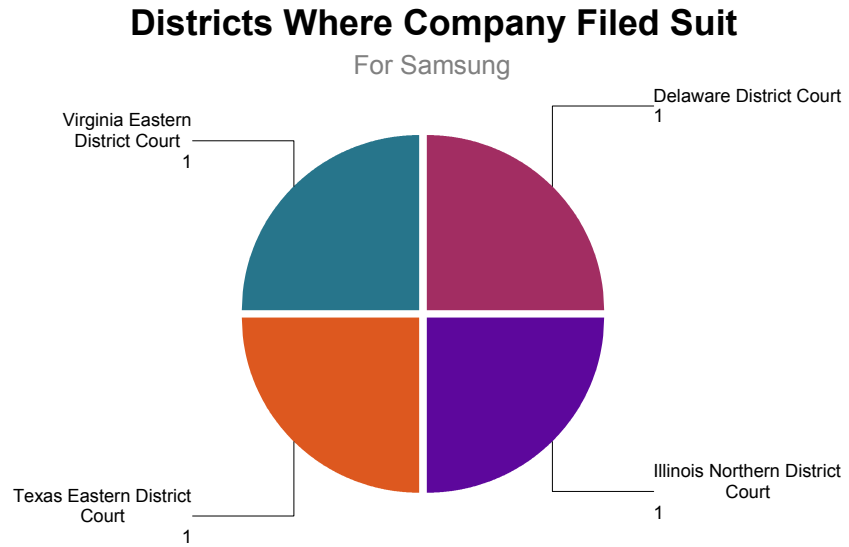

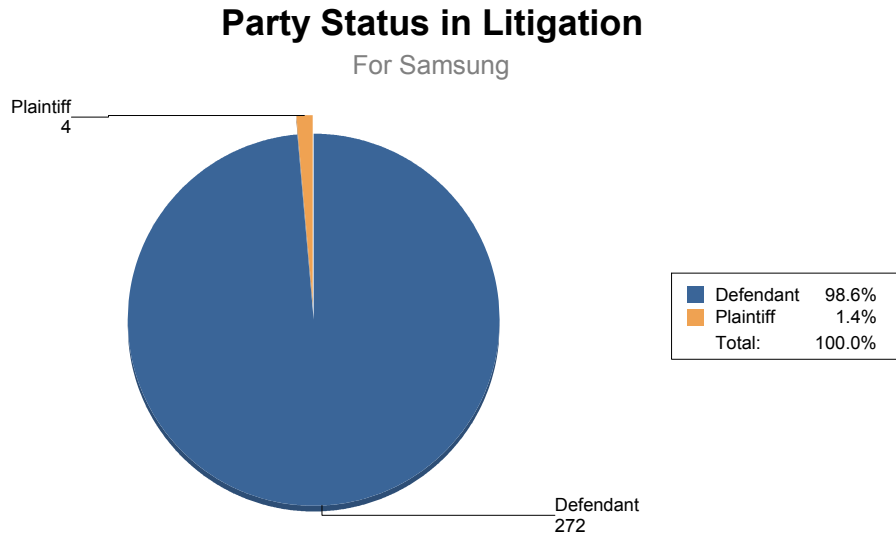

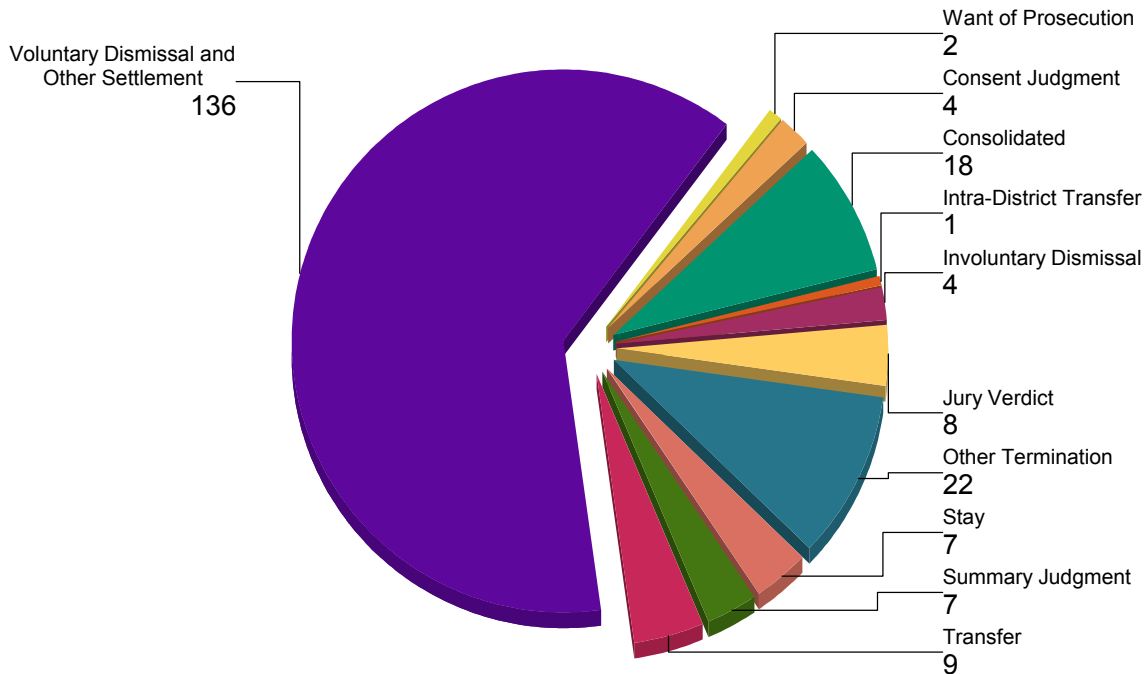

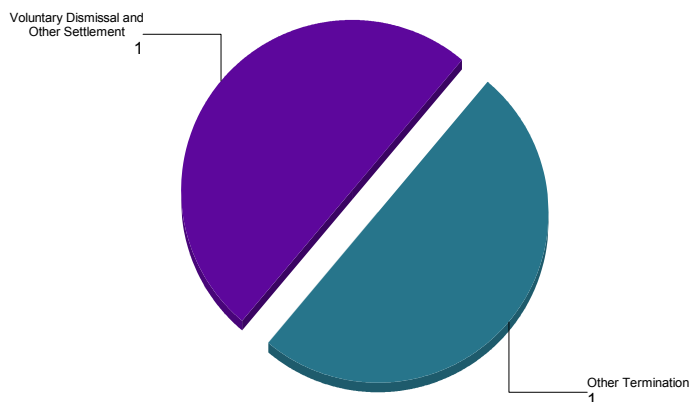

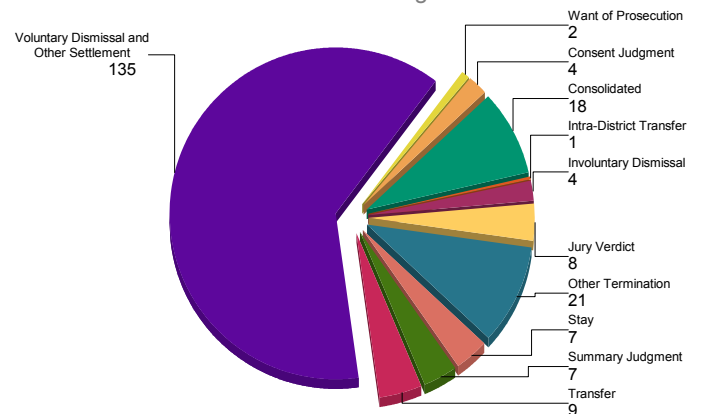

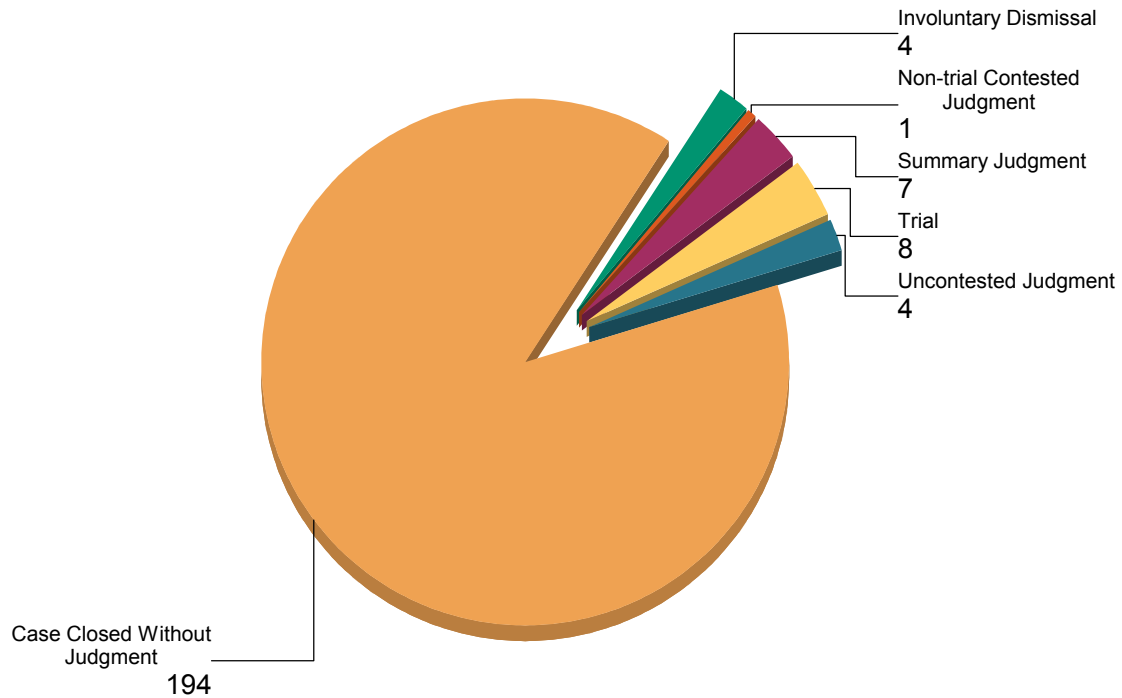

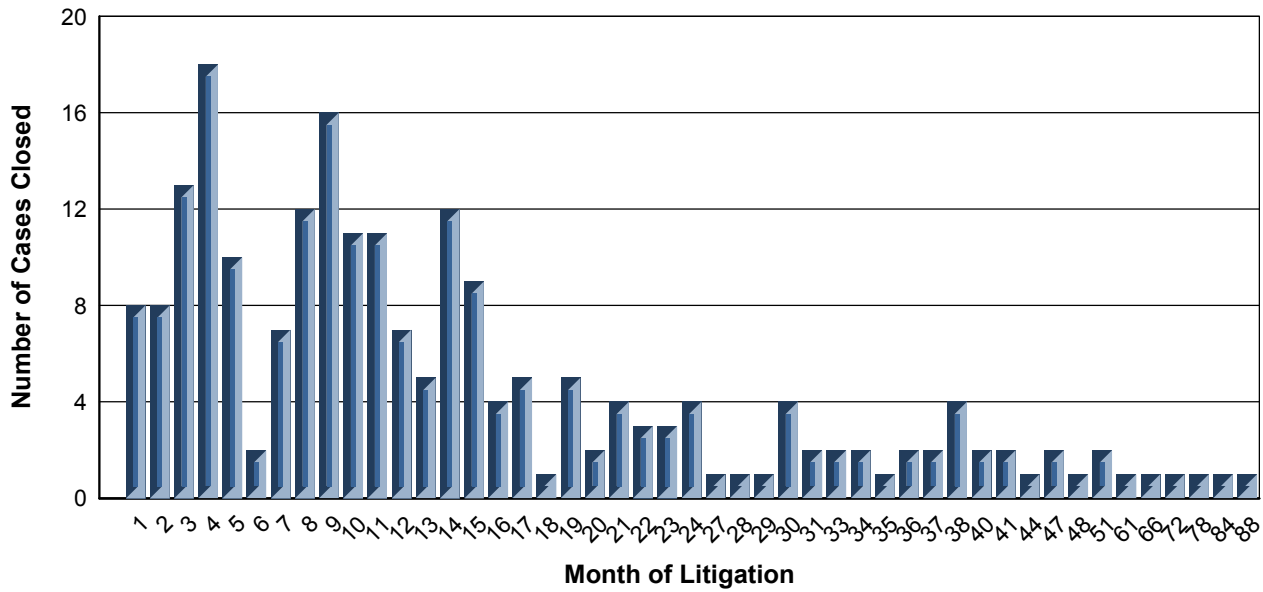
### Average Time to Case Termination, by Party Status

### Cases Closed Each Month of Litigation

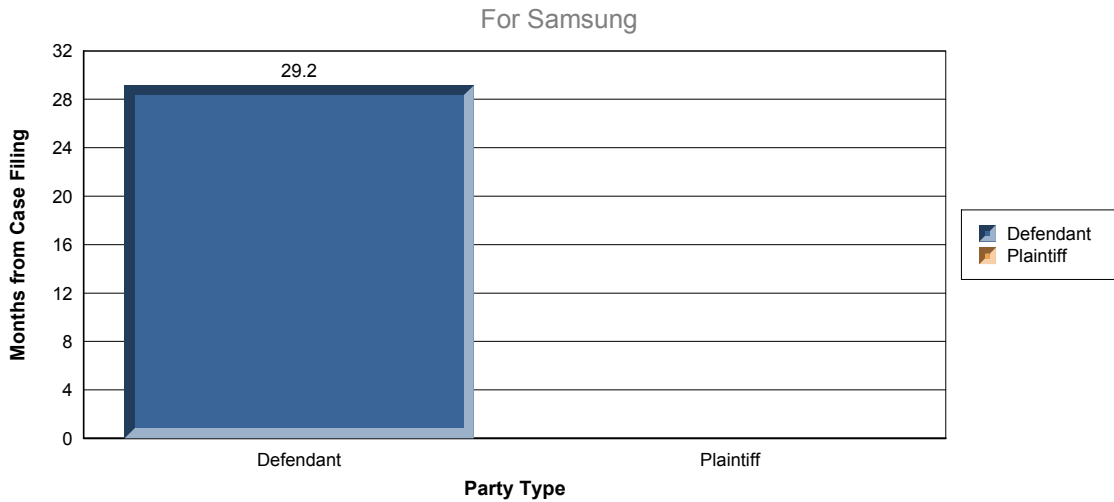

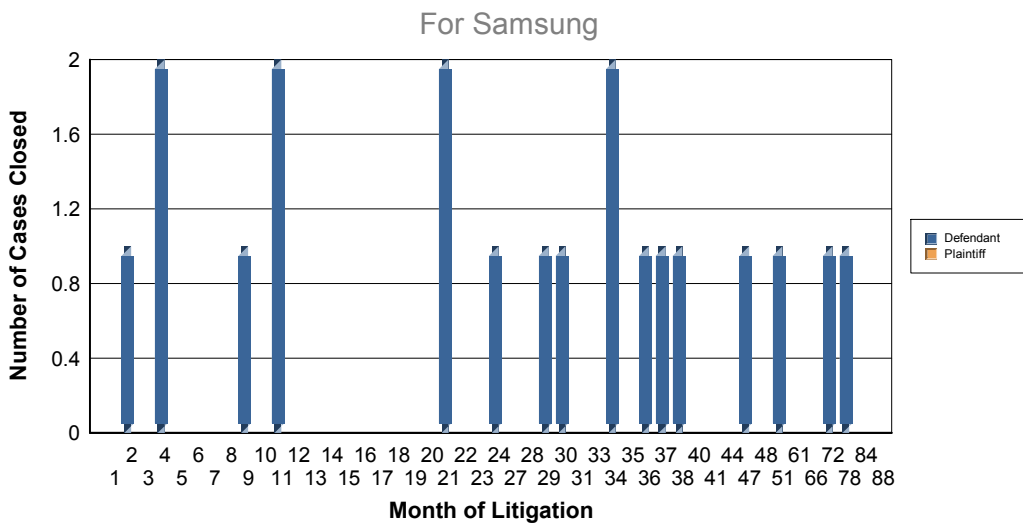

### Cases Closed by Contested Judgment Each Month of Litigation

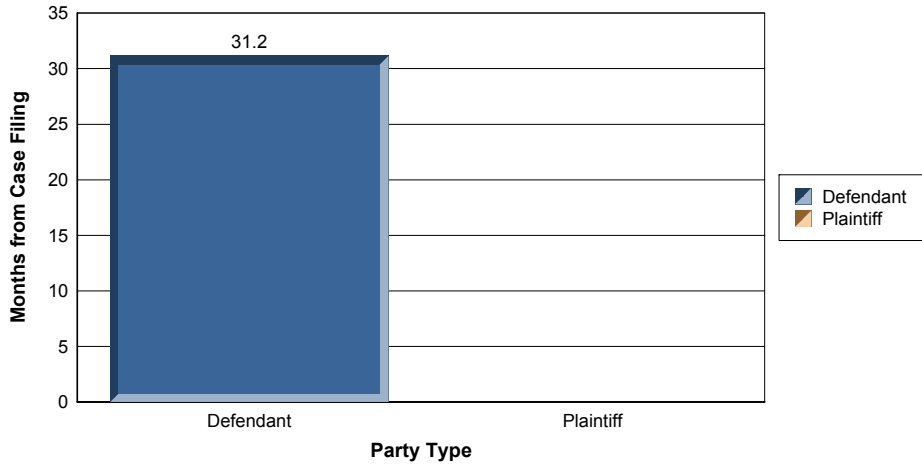

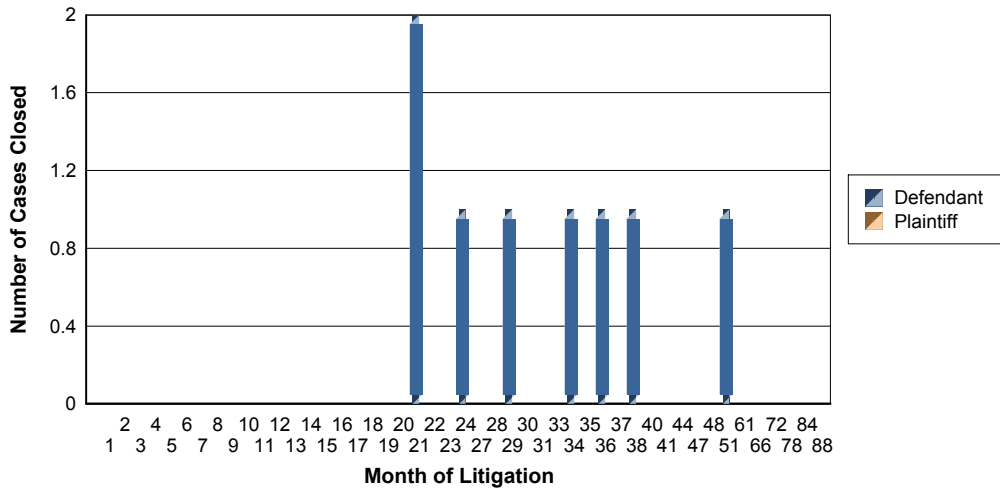
### Average Time to Trial Judgment, by Party Status

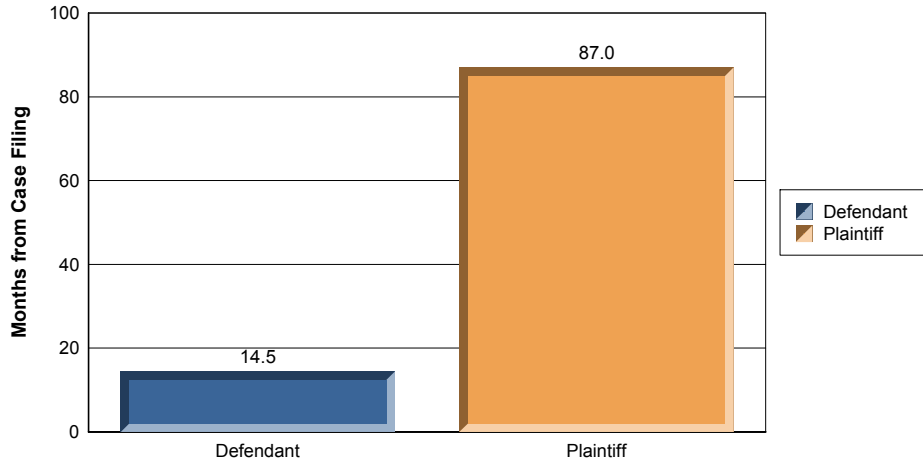

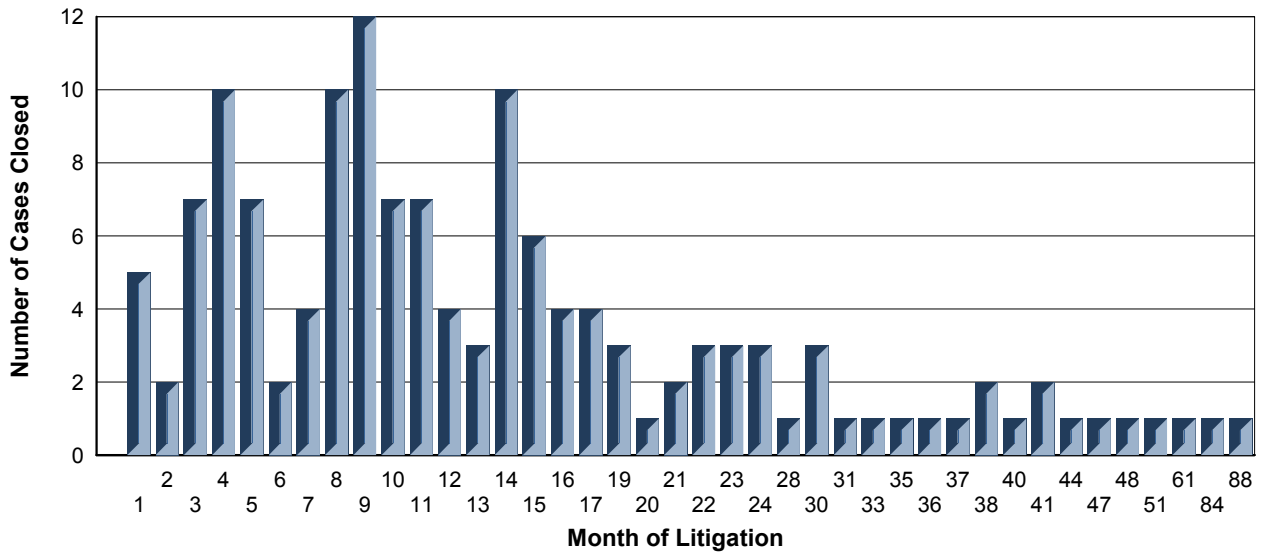
### Average Time to Settlement

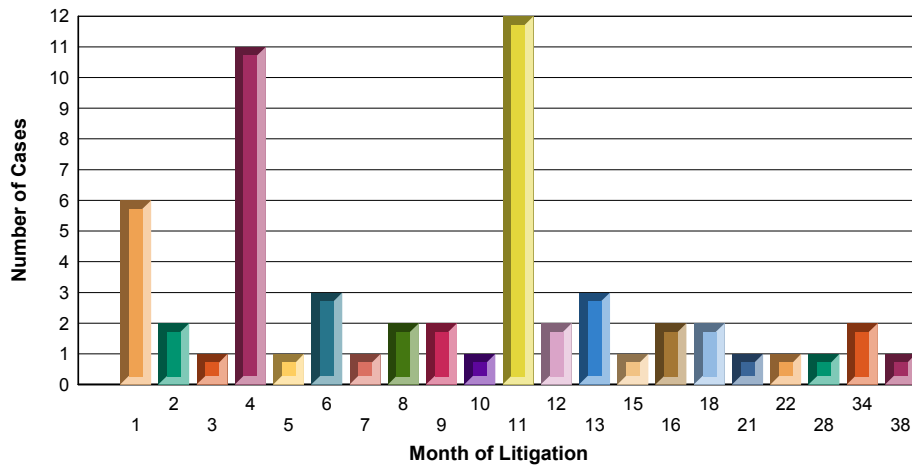

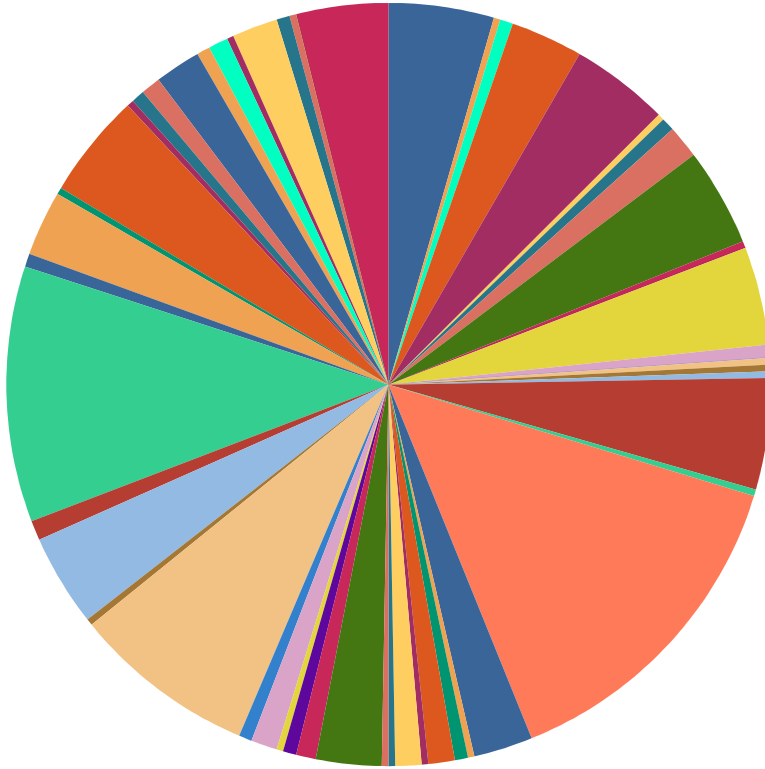
