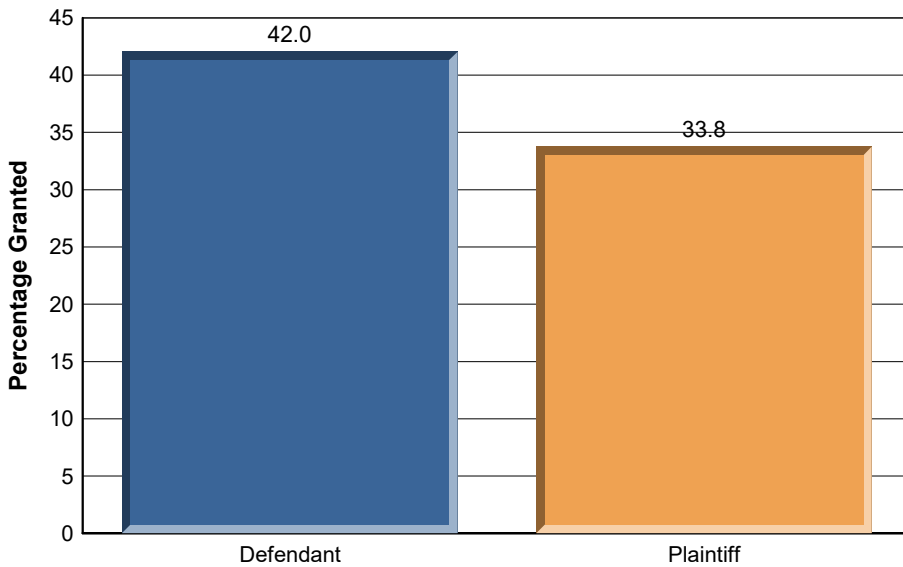

by Party Status



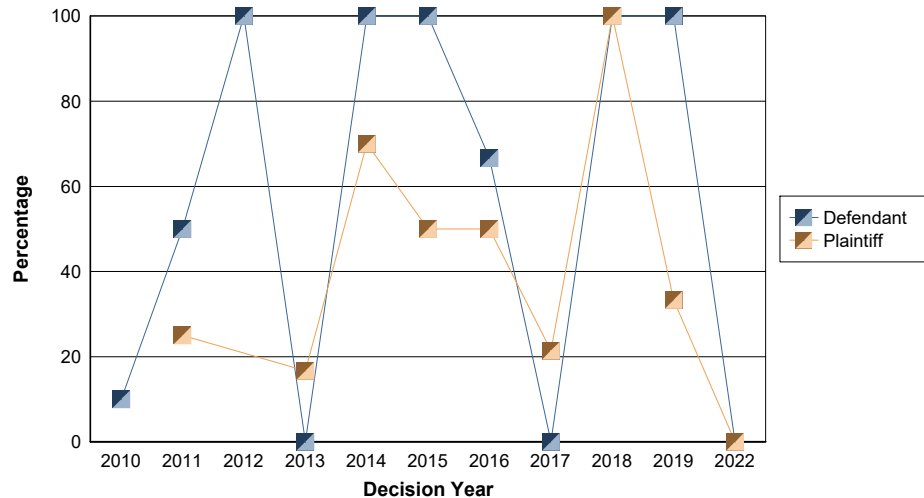
Overview:

This report covers discovery motion decisions in patent cases presided over by Judge Stark since March 29, 2010 and is based upon 84 decisions by that judge in contested motions found in the dockets. Of these 84 decisions, 29 were granted, 6 were granted in part, and 49 were denied. The win rate on these motions was 38.1%.

Contested Win Rates:

For the period covered by this report, the win rate for movants on contested motions is 38.1%. Variation from year to year and by movant is shown below.

Yearly Win Rates by Movant

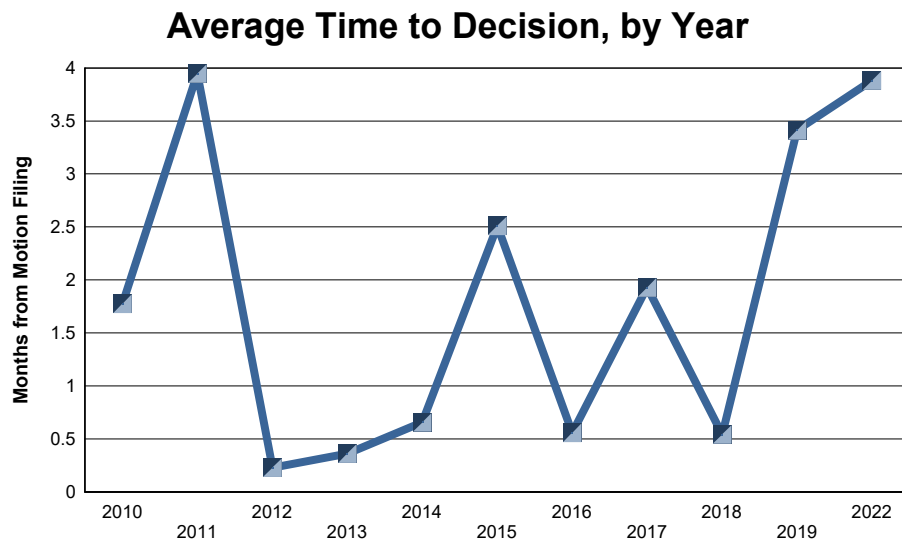

Time to Decision:

The average time from motion filing to decision was 1.4 months. For motions that were granted, at least in part, the average time to decision was 1.1 months. For motions that were denied, the average time to decision was 1.6 months. The variation from year to year in time to decision is shown below.

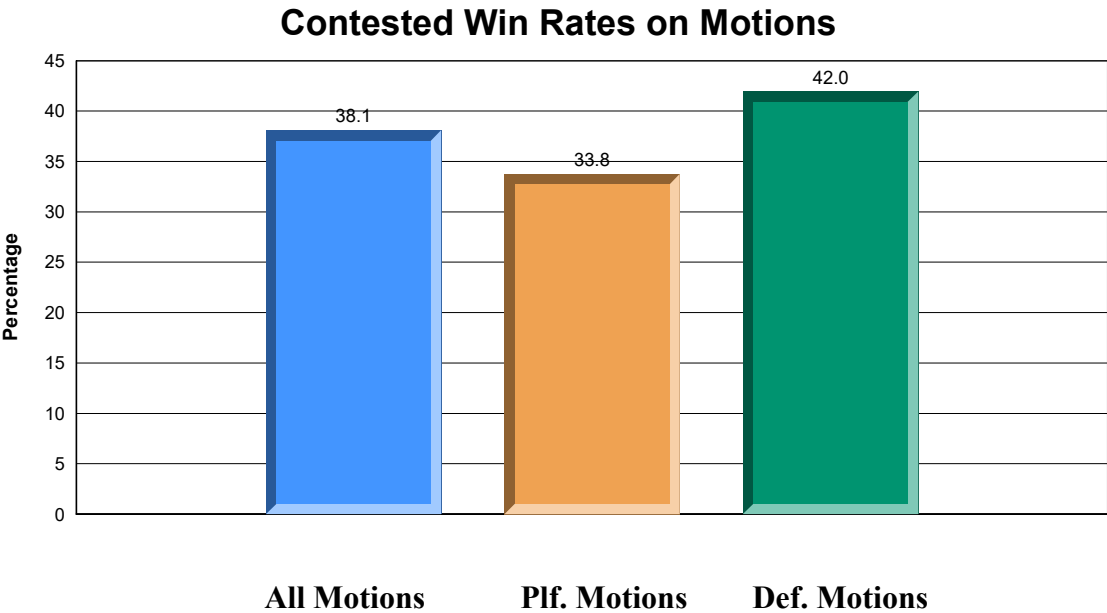

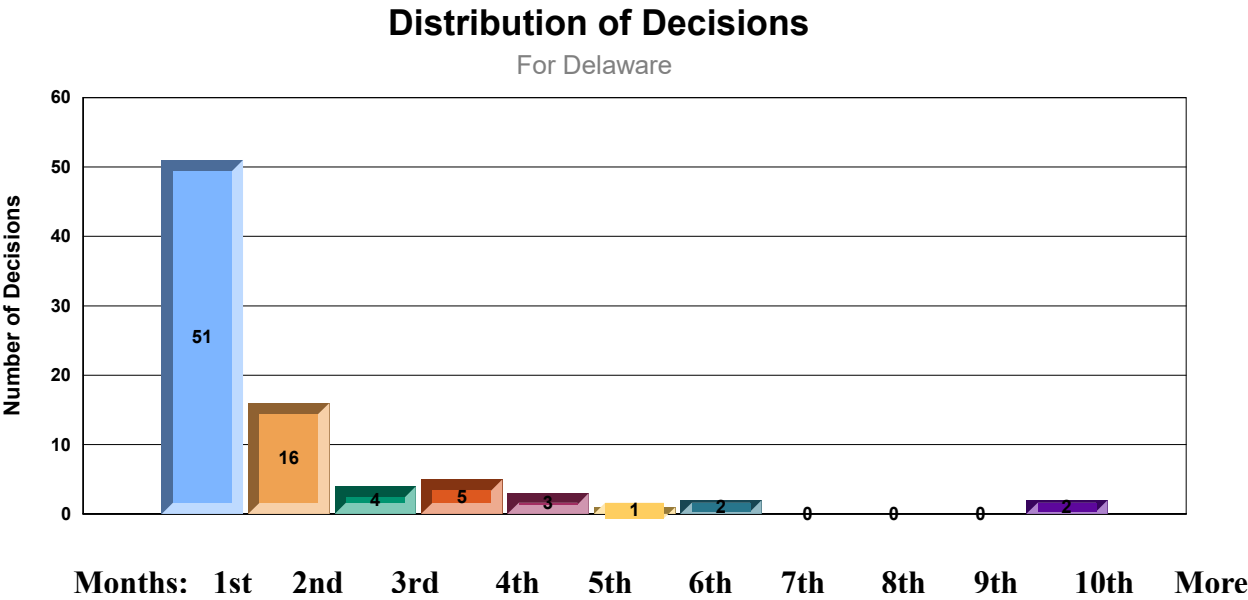
Delaware
