

Overview:

This report covers contested dismissal motion decisions and specifically covers 330 decisions in motions found in the dockets of the court. Of these 330 decisions, 101 were granted, 174 were denied, and 55 were granted in part and denied in part. Decisions of retired judges are not included.

Contested Win Rates:

For the period covered by this report, the win rate for movants on contested motions is 38.9%. Variation from year to year is shown in the chart above and in the table below.






Contested Win Rates by Movant: The win rates for these motions, by movant, are shown in the chart to the left and in the table below.

Time to Decision:

The average time from motion filing to decision was 4.9 months. For motions that were granted, at least in part, the average time to decision was 5.2 months. For motions that were denied, the average time to decision was 4.6 months. The variation from year to year in time to decision is shown below.


