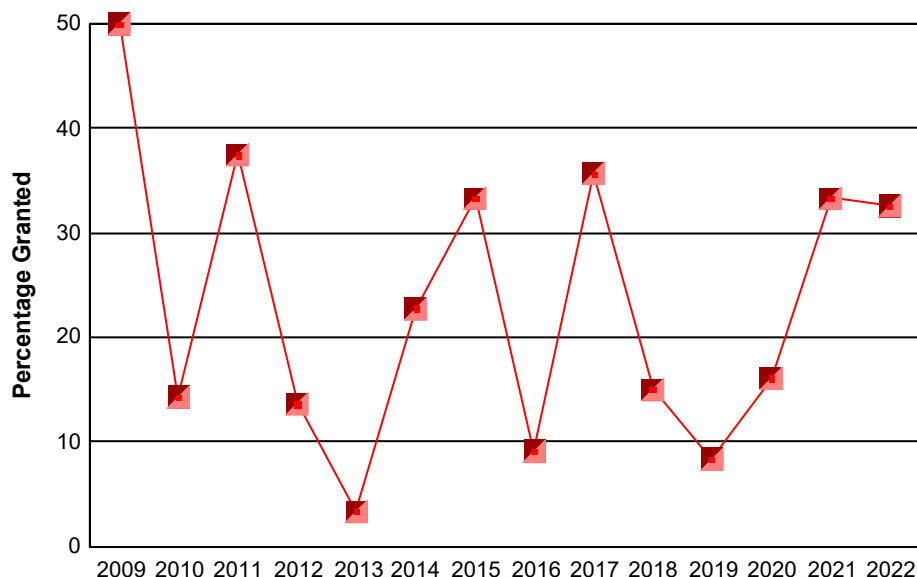

Win Rates on Contested Motions



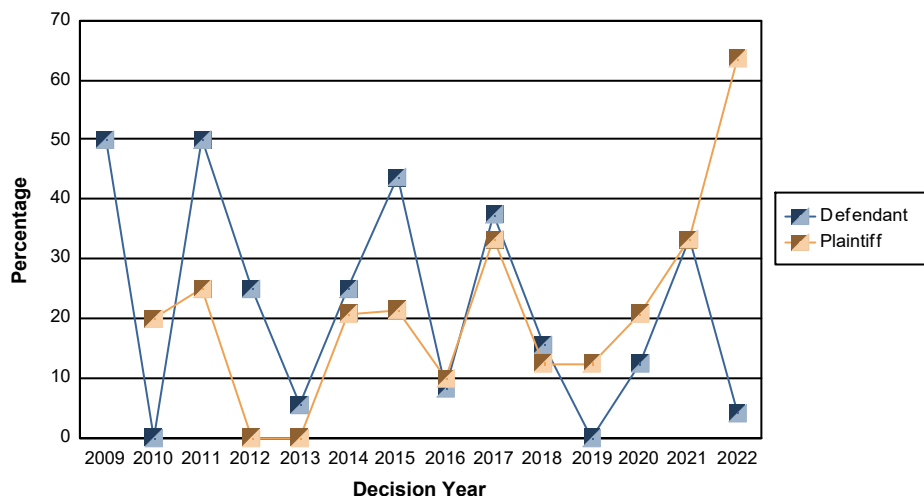
Overview:

This report covers Expert/Daubert decisions in patent cases in Delaware district court since December 11, 2009 and is based upon 211 decisions by Judge Stark in contested Expert/Daubert motions found in the dockets of the court. Of these 211 decisions, 30 were granted, 31 were granted in part, and 150 were denied.

Contested Win Rates:

For the period covered by this report, the win rate for movants on contested motions is 21.6%. Variation from year to year and by movant is shown below.

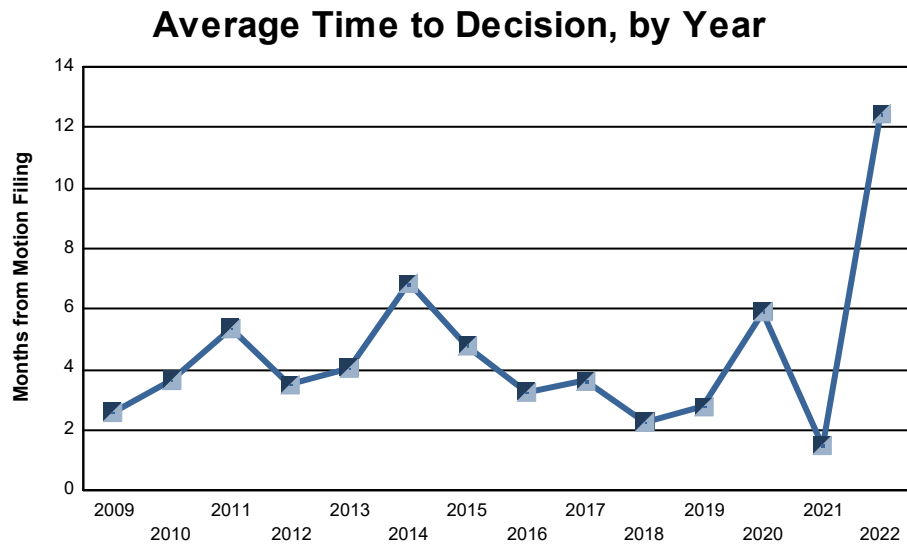
Yearly Win Rates by Movant

Time to Decision:

The average time from motion filing to decision was 5.1 months. For motions that were granted, at least in the average time to decision was 5.4 months. For motions that were denied, the average time to decision was 4.9 months. The variation from year to year in time to decision is shown below.

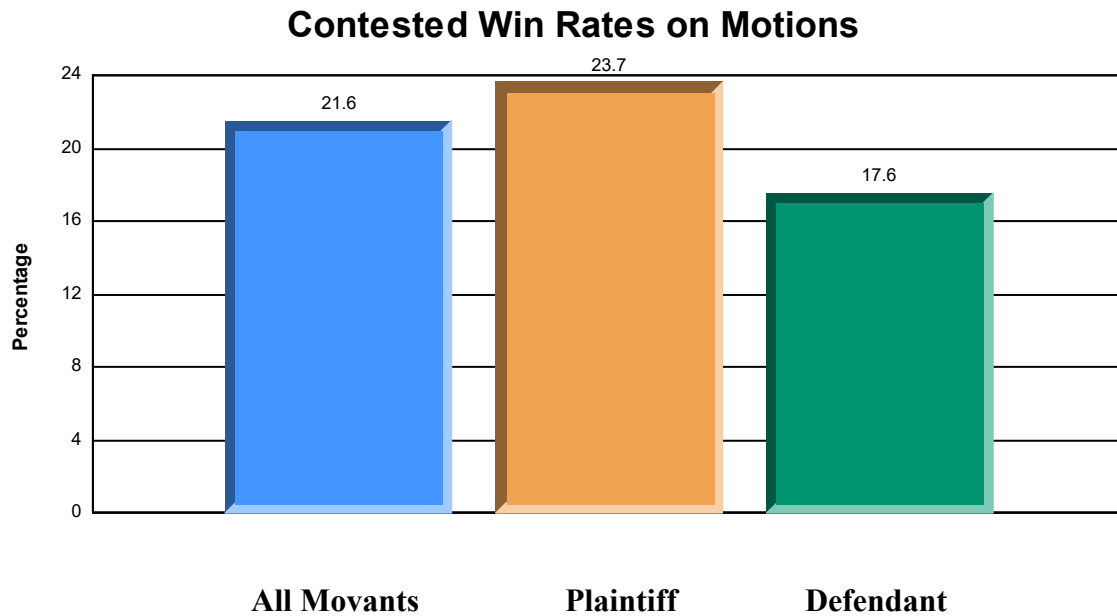

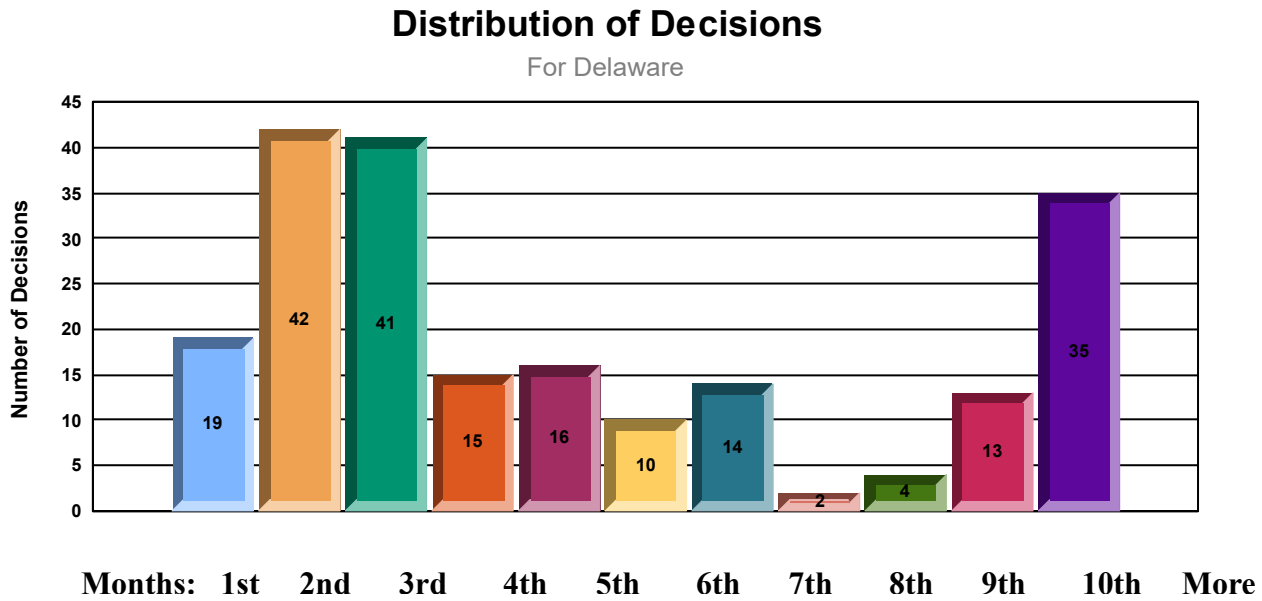
