

Win Rates on Contested Motions




Overview:

This report covers Post-Trial motion decisions in patent cases in Delaware district court since February 23, 2011 and is based upon 56 decisions by Judge Stark in contested Post-Trial motions found in the dockets of the court. Of these 56 decisions, 7 were granted, 10 were granted in part, and 39 were denied.

Contested Win Rates:


For the period covered by this report, the win rate for movants on contested motions is 21.4%. Variation from year to year and by movant is shown below.

Time to Decision:

The average time from motion filing to decision was 6.8 months. For motions that were granted, at least in part, the average time to decision was 5.7 months. For motions that were denied, the average time to decision was 7.3 months. The variation from year to year in time to decision is shown below.




