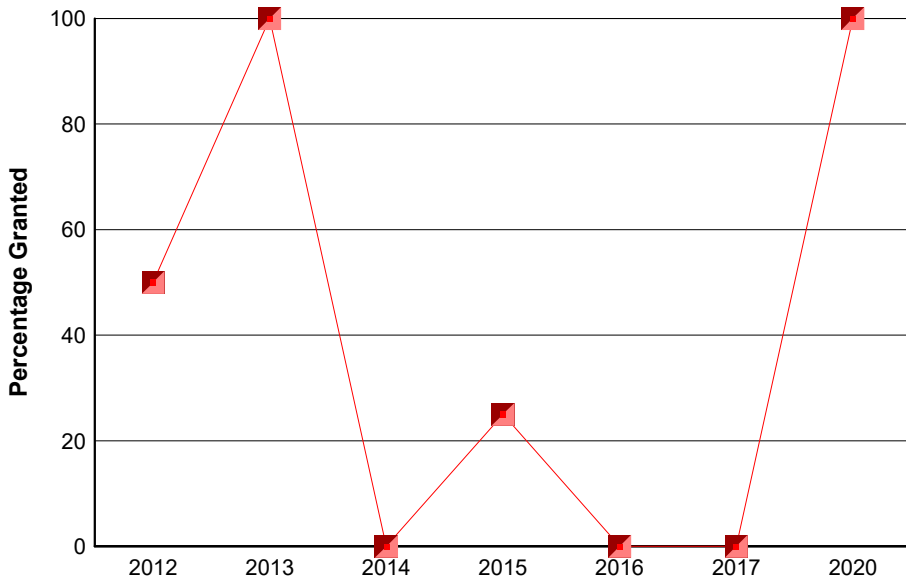

## Win Rates on Contested Motions



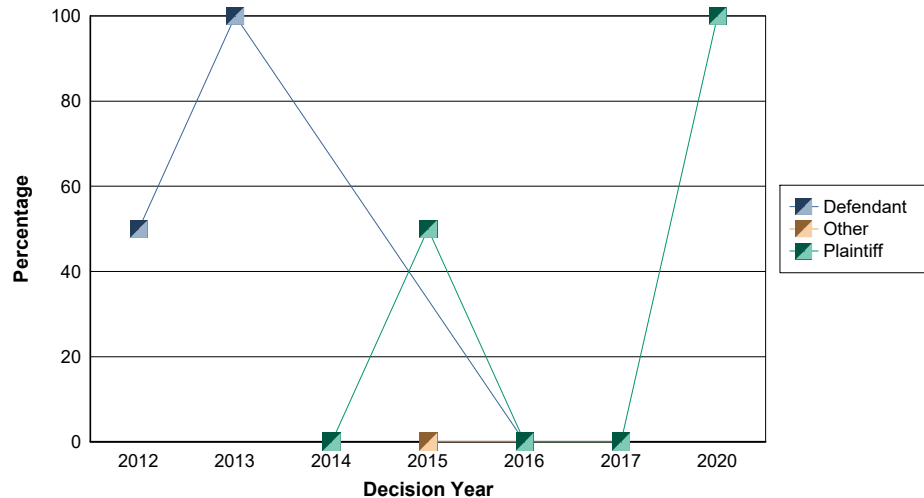
### Overview:

This report covers Sanctions motion decisions in patent cases in Delaware district court since February 08, 2012 and is based upon 13 decisions by Judge Stark in contested Sanctions motions found in the dockets of the court. Of these 13 decisions, 3 were granted, 2 were granted in part, and 8 were denied.

### Contested Win Rates:

For the period covered by this report, the win rate for movants on contested motions is 30.8%. Variation from year to year and by movant is shown below.

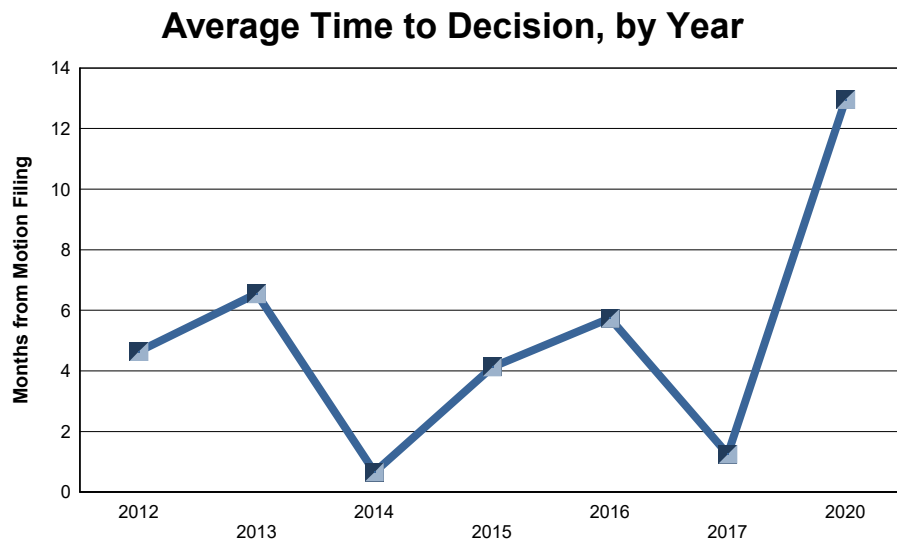
### Yearly Win Rates by Movant

## Time to Decision:

The average time from motion filing to decision was 4.8 months. For motions that were granted, at least in part, the average time to decision was 5.3 months. For motions that were denied, the average time to decision was 4.5 months. The variation from year to year in time to decision is shown below.

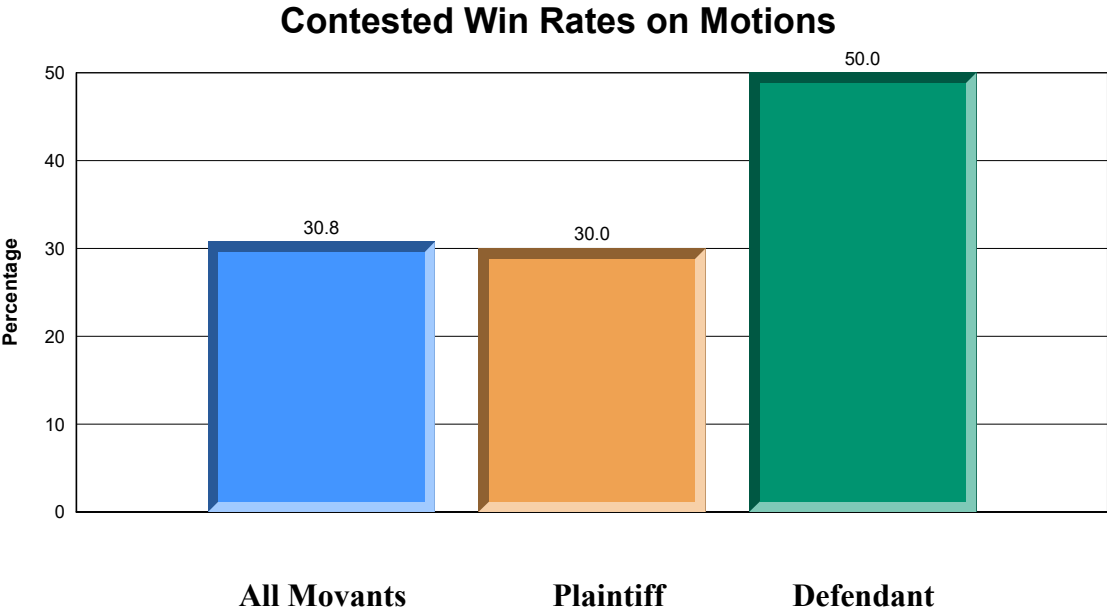

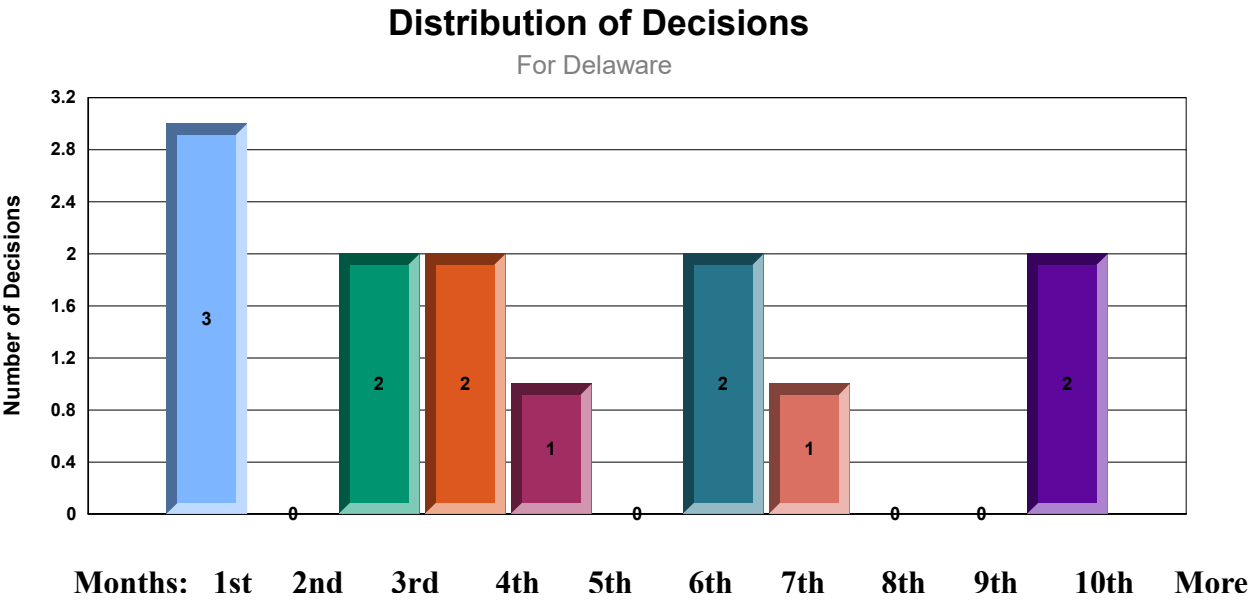
**Delaware**

The dockets of patent cases in Delaware were examined to identify decisions on contested Sanctions motions by Judge Stark. The number of decisions found, the number granted, and the number denied are as follows:
